BLEDSOE FILES PETITIONS Workers Obtain 3700 Names to Nomination Blanks

of Jurist for Mayor in Eight Hours In the record-breaking time of eight hours, the petitions to place former United States District Judge Benjamin F. Bledsoe's name on the May 5 primary election beliet as candidate for Mayor were filled yesterday: 3700 signatures were secured, with only 500 required, and the petitions were filed with Cliv Clerk Dominguez at the City Hall at 4 p.m.

The blank nominating petitions were obtained from the City Clerk at 8 o'clock yestorday and taken to the Bledsoe-for-Mayor campaign headquarters at 425 South Spring street. In order to make the nominating petition representative of all parts of the city, petitions were distributed to the fifteen district campaign headquarters, including the East Side, Hollywood, Wilshire, Los Angeles Harbor, Highland Park and other sections of the city.

Within a few hours the filled petitions came rolling in to the campaign headquarters so that at 3:30 o'clock, Judge Bledsoc, Campaign Manager George B. Bush and Mrs. Sarah E. Ash, in charge of the women's division of the Bledsoc-for-Mayor campaign, started for the City Hall with the great stack of signed petitions. They were filed with the City Clerk at 4 p.m., just eight hours after the blank petitions were taken out.
Judge Bledsoc and Campaign Manager Bush expressed gratification at the rapidity with which men and women in all parts of the city skraed the petitions, and Mrs. Ash reported that signatures to the petitions were easily obtained.

City Clerk Dominguez said that the petitions would be immediately cheeked. The maximum number of signatures permitted by the State law to be filed is 1000, so that the 2700 additional signatures will be held in reserve, for use, if necessary. It is expected that the petitions will check high as all distributors were instructed to secure names of only registered voters.

Judge Bledsoe said that now that his resignation is effective and that he is once more just a citizen and a taxpayer of Los Angeles, and had illed his nominating petition, he felt that the campaign was on in earnest.

"And I am in this campaign to win," said the former judge.

Former Judge Bledsoe's petition was the only one taken out yesterday, and it is almost certain that no additional ones for any office will be taken out, as no filled petitions can be filed after the City Clerk's office closes this evening. To date a total of 195 candidates have taken out petitions for circulation, of which 164 were for the Council.

With the practical ending of the taking out of petitions yesterday, two contests were decided. City Attorney Stephens was unopposed. No petitions other than his were filed for the office of City Attorney and he stands elected by acclamation, as was the case at the primaries two years ago. His name will be the only one to appear on the May 5 ballot as candidate for City Attorney. The other result is the re-election of the present Board of Education. While several other names of candidates will appear on the May 5 ballot for the board, these candidates are not well known. It is practically certain that the present board will receive a majority of all the votes cast for the Board of Education candidates at the primaries and will be declared elected then The present members of the Board of Education are: Robert A. Odell, president; Arthur S. Bent, John B. Bennan, Robert L. Burns, Elizabeth Louise Clark, Lucia Macbeth and Prederick Feitshans.
